This edition's topic is "RV Park equipment register and equipment maintenance"

CMCA provides a range of equipment to assist Park Custodians in their duties, especially with grounds maintenance. You should find an equipment register in the Custodian Folder that lists what has been purchased by CMCA over time, and this should be checked regularly or at Custodian handover to ensure that all items listed are still at the park.

Most parks now have a push mower, or self-drive walk behind mower or a ride-on mower. The type of mower depends on the size of the park grounds and how much grass there is to manage. We also provide a whipper snipper and spray equipment, barbecue, fire extinguisher, wheelbarrow, shovel, rake, pull trolley, garden tools, portable totes and attachments, and maybe some other smaller tools.

As we expand the RV Park network, we can determine what is essential for the operation and management of each park. Our Custodians have been crucial in providing feedback and input into what is needed at each park.

Some recent good suggestions are a ladder for each park, trolley for carting the 40lt portable totes, and a ramp for the dump point (like what is now at Ingham and Geeveston).

Portable grey water totes

As mentioned in a previous newsletter, we require all guests to have their own portable tote for their grey water capture and disposal if they do not have a fixed tank on board. This is an education process for many because they have purchased "self-contained" rigs and set off on the road not realising that simply running a hose from their grey water to the ground is not consistent with CMCA "Leave no Trace" code of conduct.

There are many options on the market, and guests can set up their own system very cheaply using the information provided on our website or in the fliers you should have available.

CMCA purchases 40lt portable totes for its parks through Outback Equipment, an online store for the RV traveller. You can pass this link on to those looking to purchase a brand tote.

These are not always in stock so may have to be ordered in advance or have somewhere to send it to for later collection.

Our park totes do get a lot of use, and as such will fail at some point. The common issues appear to be caps cracking or cap lugs breaking off resulting in leakage when the tote is being transported.

Please advise NHQ of any issues with your totes so that this can be rectified as quickly as possible.

Mowers

Mowers are an important piece of equipment for most of our RV Parks. The size and type of mower differs across the network and the brand usually depends on what is available locally.

Correct operation and maintenance of the mowers is critical to the ongoing management of the parks. Handover should highlight the proper operation of the mower to ensure the next Custodians are aware of how it works and what settings to have it on.

Many of our members have mechanical backgrounds and are willing to assist with servicing of the mower, whether this be checking belts, greasing, or changing oil filters and oil. This is very much appreciated.

To avoid future issues with the mowers here are some tips:

- Always do a pre-start check (oil levels, belts, tyres, fuel, blades).
- Do not operate with the blades below setting 3 on the deck, the shorter you cut the grass the more chance of hitting stones, branches, roots, or picking up dirt and mud under the deck.
- Operate at full revs and a lower gear. Mower engines are designed to run at higher revs, so don't put it in a higher gear and lower the revs.
- Clean the mower after use and check for any damage or change to the machine.

- Record any services in the Custodian Folder for future reference.
- If unsure, ask someone in the park or call NHQ.

Whipper snippers

Each park will have a whipper snipper or brush cutter to assist with weed management and grass control around structures and fences.

Please check to see what type of fuel the machine takes. Where possible we purchase equipment that uses straight unleaded, that then requires oil in a separate tank. Otherwise you will have to mix oil with the fuel in the ration recommended for the equipment.

Please ensure that you do mix oil into the fuel if you have a two-stroke engine, or check the oil level if it is a four-stroke engine.

We recently had to replace a two-stroke whipper snipper because the engine had melter as a result of the oil not being added to the fuel.

As Custodians, you have agreed to look after the plant and equipment in the park. This does not mean that you have to do the maintenance yourself, but you should notify NHQ if maintenance is needed.

Personal Protective Equipment

Please ensure that you always wear the correct safety equipment when operating equipment at the park. If you cannot find the gear, let NHQ know so that we can resupply you.

Generally, you will have access to:

- Ear muffs
- Safety glasses
- Gardening gloves

We do not provide steel capped shoes and expect that you will wear closed shoes when operating mowers and whipper snippers.

CMCA aims to keep its volunteers safe when at our RV Parks, and we expect that our volunteers will also ensure that they are operating plant and equipment in a safe manner.
